## **General Meeting approves PMeV Board of Management**

## Bernhard Klinger to hold the chair of the Association for another two years

The online General Meeting of PMeV – Netzwerk Sichere Kommunikation (German Association and Network for Critical Communications) has approved the Board of Management of the Association for another two years. Bernhard Klinger (Hytera Mobilfunk GmbH), who has been elected Chairman in 2019 for the first time, will thus continue to preside over the PMeV Association. Vice-Chairman and Chief Financial Officer will be Heinrich König (Airbus Secure Land Communications GmbH). Volker Hartwein (Frequentis Deutschland GmbH) will also act as Vice-Chairman at his side. In addition, the following persons will be PMeV Executive Board members: Axel Kukuk (Motorola Solutions Germany GmbH), Charly Lemberger (telent GmbH) and Peter Stroetmann (Seamcom GmbH & Co.KG).

With respect to PMeV positioning over the next few years, Bernhard Klinger explained: "Mission-and safety-critical communication will rapidly develop in the broadband direction in 2021 and over the next few years. New rules of engagement, new challenges and new players will characterize and shape the overall development. In this environment, we will continue along the path we have taken: Promote the expansion of our pool of experts, further develop the "broadband in professional mobile radio" topic both at national and international level and simultaneously maintain the market for narrowband applications in the interest of many customers of our member companies."

To fulfil these objectives, the PMeV will consolidate and expand its networking in the political, regulatory, business and media environment, further professionalize its work and adapt its structures to the challenges of the future.
